Call to Order

Approval of Minutes

Committee members reviewed the minutes from the October meeting. CAC member moved to motion and approved the minutes with one update on Word on the Street. CAC member seconded the motion to approve. Approved through vote.

Word on the Street – All

CAC members and attendees shared Word on the Street on the following topics:

- Brief KDRV 12 headline: Oregon Health Authority (OHA) is going to create a pharmaceutical board regarding the merge article with Kroger/Albertsons. This merger could impact pharmacies in Oregon, especially those in rural areas. Oregon has the right to review and accept/not accept mergers and can take more than a year to be completed. The OHA reviews mergers that can affect health care, there should be an opportunity for consumer feedback.
- Ashland homeless update: Ashland added a new 30 bed homeless shelter, which includes space for an emergency weather shelter. The City Council is passing a criminalization ordinance regarding camping, that would make overnight camping illegal and a misdemeanor. Police will be giving two warnings before citing those camping. Community members have expressed concern because due to not enough spaces for the homeless, they are having to camp outdoors.

CAC Future State - 2024 and Recruitment/Term limits - Dave and Sandra

- CAC Future State-
 - Looking at growth and meaningful ideas for 2024.
- Recruitment/Term Limits
 - Starting with the Charter.
 - Term for CAC members is 3 years.
 - Propose term limits to be 6 years (2 consecutive terms), then take one year off until reapplying. Council members can continue in 2024 even if over their term limit.
 - Mid-years do not count a full year.
 - Clarity is needed at the next CAC meeting on who will be remaining on the CAC.
 - Consumer member vs partner ratio? (51% consumer member is needed)
 - There is a need to diversify the council.
