### **Food Smart Presentation** – Ashley Green

Ashley shared a presentation that she will email to the CAC regarding the rollout of a new nutrition benefit, and Foodsmart discussed their program, including the following highlights:

- Bringing assistance through registered Nutritionist/Dietitian with the least cost.
  - If members are struggling with food and/or nutrition, they can go to the dietitian for advice.
- 24x7 assistance.
- Food can be delivered or be ready for pick up.
- Makes food fun, easy, and less stressful.
- Provides better ways to improve health.
- Eliminates decision making stress to help make good decisions to be excited and proud about.
- Foodsmart Platform presentation was given by Madisson Reed. The platform can be accessed by phone or web, with the following functionality for members:
  - Help with online ordering and show how to get food for free.
  - Help review bloodwork and see referrals and information from Providers.
